## LEASE TYPES

### ACMI (A.K.A WET OR DAMP LEASE)

ACMI leases can be a great option for sudden capacity shortfalls or when an aircraft goes unavailable. The lessor provides the **A**ircraft, **C**rew, **M**aintenance provisions, and aircraft **I**nsurance, and retains operational control of the aircraft. The lessee is usually charged an all-inclusive price for the aircraft (traditional charter) or charged for a minimum number of hours at a fixed rate per hour (block hours charter or ACMI), with additional hours charged at a defined rate.

### OPERATING LEASE (DRY LEASE)

With an operating lease, the aircraft is leased for a fixed monthly rate, with an agreed upon maximum number of hours flown per month (with additional hours typically charged at a defined hourly rate). The lease rate excludes all operating and variable costs and there is usually an additional hourly maintenance reserve charge.

The operational control of the aircraft, crew, insurance, and all expenditures are the responsibility of the lessee (or a lessee-designated operator). The lessee, or proxy, typically has the infrastructure and regulatory control required to run a single aircraft or fleet of aircraft. Full rental payment may be deductible as an expense.

### FINANCE LEASE (DRY LEASE)

A finance lease usually derives from a bank or finance house, which supplies the aircraft under the stipulation that operational control falls to a specified operating party—like ACASS. The operating party crews, maintains, and insures the aircraft at the lessee's cost. This type of lease may be treated as a loan for bookkeeping purposes and could include a purchase option at the end of the term.
